12 concepts read to the business meeting.

Old business discussed for the Tuesday worthing meeting hanging a flyer in the wothing Hospital, it is not H&I item and continued to be discussed from last business meeting. It has been discussed that the patience to have information to get them to the meeting, discussed that the standard meeting poster is not seen as appropriate for those in need in the hospital. The poster uses wording including 'alcohol' on the poster and this is deemed inappropriate as NA identifies alcohol as a drug. The poster is available and the GSR's asked to understand more about the wording as NA identifies powerless over addiction and not the substance. It is said that the hospital is 70% of those in the ward are there for alcohol related medical need and the meeting ask if the wording is not inclusive or clear to the addict who still suffers. The service member is concerned the newcomer will not come to what is deemed an addict meeting when they have issues with alcohol. Those who discuss the wording were asking if they are able to word this with our addiction and is it reaching the newcomer.

• The wording is to be discussed – AOB for the end of November, this will be the third ASC it is discussed.

The chair advised that the members are autonomous and thereby trusted to use the groups discretion and able to decide what it is that is used to advertise the meeting in the hospital. The chair confirmed that the poster is not being discussed for change of wording for literature review.

Each group is autonomous and the chair advised this as well as carrying the message to the addict who still suffers, do it consistently following the guidelines, whilst teaching members to carry the message. The members did not conclude this issue. Sussex Area Online Committee member explained that reaching the suffering addict and the NA logo being used – "drugs including alcohol" and PR work can be done in the hospital.

A GSR service presentation was delivered to the group – feedback from this was 3/24 GSR's felt confident and able to fulfil their role as GSR to their group.

The meeting does need a summary from the meeting.
