HMP Ford.

So far 7 of us have applied for vetting. Some of you will have received the vetting emails? Having made a phone call to the vetting coordinator, we have agreed a simpler way of starting the process off.

I have also been invited to attend and give a 5minute presentation to all the heads of department, at the next reducing reoffending meeting on 5th April @10am. I want to be able to take another committee member along too.

William Collier House: Brighton
