#### **HMP Lewes:**

We have had some recent email exchanges and phone conversations with The Forward Trust (formerly RAPT) at Lewes Prison. We were recently invited to attend a meeting with them at Lewes Prison on Tuesday 4<sup>th</sup> December. Two of us went along as arranged. We had discussions and a Q&A session: Security procedures and protocols to be followed. Vetting/Gate passes, ID etc. \* Shown where and when the meeting will take place.

We also met with the staff and some inmates on the wing itself.
