RD. Report. RD and Alt RD

EDM met once ? ECCNA Egypt 2020 postponed 2021 Kiev Ukraine still going ahead. Winter EDM in Rome Italy is likely to be held virtually though no final decision made as yet. As has previously been reported, a group of NA members, calling themselves the Autonomous Region of NA, petitioned the court in Los Angeles, accusing NAWS of several breaches of the FIPT (Fellowship Intellectual Property Trust). There was an initial hearing in front of a judge. As a result of NAWS lawyers issuing a 'demurrer', or objection, the case was dismissed, with no opportunity to appeal the decision. The court documents are attached, and a further statement from the WB (World Board) will come after their next meeting.

This is, of course, good news. The reality is that this cost NA more than \$218.000 in court & legal fees; money that should be being used to carry the message.

As a result of Covid-19 the USA has developed 2 schemes similar to furlough in uk. See documents in pre-region report

1. EIDL (Economic Injury Disaster Loan) is a low interest loan, of up to \$150,000, with the

possibility that some of the loan will be 'forgiven', or forgotten about. This part of the scheme has not been taken up, as it would be in breach of our traditions.

2. PPP (Payroll Protection Programme) is a larger, longer term, means tested loan, that is similar to the UK Furlough

Scheme. We were offered, and have accepted \$676,740.00 and there is ongoing discussion about 'loan forgiveness'. The loan is directly based on the amount of tax (payroll, state & tax refund, rather than any kind of gift.

WCNA38 (World Convention in Australia, 2021o 3 year cycle)

At the last Conference Participants webinar there was a discussion about the possibility of postponing WCNA38 until 2022, due to uncertainty as a result of the pandemic and its' effect on our members' ability to travel safely, if at all. The straw-poll result was 92% in favour of this, so discussions with the host committee, venue etc will happen now. Any change from WCNA38 happening in 2021 will require a vote by the Delegates; more will be revealed. Following world convention will be in 2024.

NA Online project still running.

The last webinar for Conference Participants - RDs from 'seated' Regions, and Zonal Delegates from Seated Zones, all of whom

can attend the WSC (World Service Conference) - spent some time discussing online, or virtual meetings. The main focus is to develop some literature and guidance around best practise. It will be an IDT (Issue Discussion Topic) for the 2020 - 2022 cycle,

Some literature will be created to add to the Local Services Toolbox (information here).

How online groups can become a part of our service structure will be discussed at the next webinar on 31.10.2020. I hope to report about that here. NAWS is in the process of collecting Delegate input for a Fellowship-wide Survey on this subject. There are many issues that require to be sorted out relating to the registration and incorporating online meetings into the service structure. When this is available, we will let you know.

SPAD project continuing.

Meanwhile back in the UK. Should this region be recognising Online NA meetings.

Point of Information. Motions need to be brought to RSC by RCMs in order for issues to be discussed this can occur during the process of a RSC meeting.

The RSC Task Force Workgroup is continuing to research and post the current Government and NHS guidelines around meetings

- both Recovery and Service meetings. As changes in the guidance occur they will be posted here: https://ukna.org/covid19

The future of virtual NA, including on-line Groups and their place within our service structure will continue to be discussed in future Conference Participants webinars (Virtual meetings are already listed on the NAWS website). There is currently no plan to incorporate on line meeting into the wider service structure. The latest webinar was on31st October. We will supply a link to the notes when available.

Open world service webinars are there for anyone to access and are available on line.

14th Nov office operating one day week +/- a half day.

Preston office leased from 1/11 due to start functioning January 2021 likely to be open 3 days a week. 3 new Directors in process of appointing still another vacancy soon due to rotation. Currently loosing about £1K/ month.

Q. Lease and available funds. Is there a break clause in the lease that enables closure in the event of perpetual lockdown. Plus Brexit effects. There is a built in safety net to allow delay in starting function. Viability impossible to assess due to uncertainty of Brexit. 3 months rent free. Will be

functional for at least 18 months. Q. pondering on significance of commitment to one source of supply? Route of supply for the future. We hope that our membership will continue to purchase through UKSP Closure 16th December last order date for stock take and move of stock. R. The existing freedom of choice as to where we buy our literature will persist. UKSO will aim to remain competitive. Q.What is the lease on Preston. ²R. 5 year lease with break clauses. This is the exciting culmination of a lot of hard work by directors and others since 2017. it is hoped that the aims of the vision committee to ensure the viability of UKSO is now bearing fruit.

New Years Eve and New Years Day function. Motion that this become a WS fund raiser. Is that ok. Not normal process of fund raising. Looking for volunteer. Motion can be processed in advance so that attendees ore aware of the final recipients of funds raised. Motion passed with no objection. Both UK region and UKCNA 31 are in a reasonably secure financial state. UKNA does not have a fund raising committee. UKCNA is used to putting on fundraising events.

Policy on donating funds to WS explained. Suggestion that everything above our prudent reserve should be sent to WS.

Guidelines to ratify.

Coms² variations. Have been produced by the committees. Ratified without dissension WhatsApp guidelines for online meetings. Ratified

Online share revue committee re guidelines for approval of online shares. These have not been circulated. Some have received them through working documents.

Motions

North East London. To produce a world wide approved pamphlet detailing the actions to be taken. Disruptive/predatory behaviour. Seconded NW London. There are currently several pamphlets on disruptive behaviour approved by various bodies within NA this motion is to produce one conference approved pamphlet that covers f-f and online meeting. NE London currently looking at ways of helping locally.

R. many regions produce their own guidelines. This is a relatively simple process.

Worldwide guidance is much more complex and needs to fit with the WS strategic plan. Not possible to cover every specific situation. There are several cultural differences world wide. The proposal is therefore unrealistic. The regional literature should be sufficient if not then it should be rewritten. It could then be added to NA resources for reference to other communities.

NE London reword to apply to regional approval rather than world wide.

There was a motion passed in Jersey re producing a safeguarding leaflet. This is still to be acted on. Straw Poll for Naws -approval no support.

Straw Poll for Regional approval- more support. This item will be returned to the Area.

The current resources are added to the working documents.

UK H and I Subcommittee. Chair emphasised the value and appreciation of all the hard work that has been done over the years by this committee.

Motion is to fold this committee which is currently being supported by the UKRSC sub committee itself working at half capacity. This is no longer sustainable.

The lack of servants on the H and I committee has been a long standing problem.

The committee effectively no longer exists so the motion is not necessary.

Clarification of fate of the Prison Sponsorship committee. Would be accountable directly to Region Experience is that a non functional committee is better to fold that be propped up. It is not likely to be re-established if continuing to limp on.

This has recently happened with the FD committee.

The motion is necessary as this committee has been limping on for years. A new committee can only reform if the existing committee ceases.

When the FD sub committee folded distance sponsorship was transferred to Communications committee.

The committee has had no chair nor treasurer since August those standing in are no longer in a position to do so.

No strong objections to this motion. It is therefore passed.

It is hoped that this will stimulate the formation of new vibrant committee.

Public Liability Insurance.

Several suggestions have been made by individuals. Renewal is gong to be a great deal more expensive than was suggested by the quotes given at the last RSC. Most insurance companies will not cover a meeting associated Covid outbreak.

Plea for information.

UK wide policy should be instigated in preparation for the demand from venues.

Time to form a working group. Maybe approach AA and other 12 step fellowships.

Benitta offered to be involved.

NA is classified as 'vulnerable people' by some venues. Confirmed by several areas.
