Bids for hosting Region:

May: W. Yorkshire bid for May Region - Close to Leeds city centre. £840 for the weekend. No one objected.

Ratifications:

Hannah to be ratified as Region Tech – she will be responsible for live streaming future Region meetings: Concept 4 and a job description was. After a delay while clarification was obtained around the role, Hannah was eventually ratified.

Reese to be ratified UKSO Director. Job description read out and Reese questioned. UKSO have already unanimously approved Reese. Reese was voted in.

RCM Reports, points of interest

Chiltern and Thames Valley: Did trials for card readers and have now agreed to supply them in bulk to give to meetings on request.

Meeting Attendance Confirmation (MAC) friendly meetings: This is encouraged, information is available from UKPI

GSR Engagement: Offer food and set up an event. Jacobs Join. GSR welcome pack in Surrey.

Sussex Questions for Region:

Hastings Saturday would like Region to look into the possibility of having environmentally friendly, non-plastic keyrings. David: This has been discussed previously and previously the WSC voted against it due to cost, UKSO may well pursue this themselves. It was explained that any change would take quite a lot of time. It was suggested that the group that suggested this discuss with Sussex ASC whether to raise a formal motion for this change – this would then got to Region who would then discuss and if in agreement, make a formal motion to the WSC.

Would like to know if the possibility of an exclusive ASC for online meetings has been discussed and what the outcome was. HIGNA (https://www.higna.org.uk/) are the Highlands and Islands Group of NA and joined as a Region last year as an exclusively online ASC - anyone can join this ASC, a Dorset meeting already has. Ben to reach out to another fellow who mentioned consideration of another geography agnostic ASC.

Sub Committees:

UKComms (Tanya): Have been receiving abusive calls and emails from NA members not happy with the service, this is not acceptable. They only have a team of 4 and could do with some support, no need for advanced technical skills

UKSO (David):

UKSO are a service board who legally also have to function as a business and therefore have 'directors' – this doesn't mean they are in charge of anything in NA!

Supply issue has been ongoing from China £66,000.00 worth of stock held, buying stock to ensure they don't run short. Big shortage of white keyrings – reasons unclear. Back order of 6000 for 6 months,12,000 sold each year. Members should return 'excess' white keyrings so they can be handed out again. WSO voted against non-plastic keyrings due to cost, but UKSO will continue to look at independently.

CAR Workshop (Craig):

The Regional Delegate (Sam) and Alternate Delegate (Craig) represent UK conscience at Europe and World Service.

The CAR (Conference Agenda Report) report provides the tools for RCMs to deliver CAR workshops to GSRs.

Engagement from GSRs is required to carry groups conscience to World.

CAR is a set of motions that form the business at world service....it is how groups speak to the world

25 motions:

- 1. World board motions
- 2. Regional motions (from countries) if UK want to change e.g. plastic keyrings we can put a motion forward.

Wish to increase stipend significantly due to desired attendance at increased physical conference. We are doing very well with negotiating our lower process than private companies.
