Preparation for the EDM

General report: Planning and progress pretty much on course. Theme decided, flyers for NYE will be available for November RSC. Ned Kelly governor HMP Full Sutton Steve Johnson Director High-Security Prisons. Prison governor HMP Prison Norwich. As fellowship liaison Officer for UK H&I we presented a brief summary and ESH shares alongside Peter UK PI who gave information RE NA as a resource in the communities. Got a great link with prison governors of our aims as a fellowship to gain effective clearance into high-security prisons. Mark Docherty HMP Wakefield shared the success NA has in his prison for the prisoners. Successful attendance alongside its location being held in the visits room to avoid the clearance headache. While prison has a positive view of NA as well as it's H&I members doing service there. Other prison governors in attendance spoke of us having more experienced sure as the need for tackles the drug problem is huge and unprecedented in HM Prisons nationally. Director of High-security prisons Steve Johnson reflected to us a possible invitation to their next meeting to move forward our aims as a fellowship in carrying the message. Ned Kelly HMP Full Sutton Governor spoke of his desire to have H&I meetings starting ASAP due to HMP Wakefield's success. Overall the presentation was very positive for our fellowship. Would like to thank UK PI for the unity this creates in moving forward as a fellowship.

General report:

- **1. Literature** European office has been struggling to be supplied by NAWS US, so are short on items e.g. IP16 (for the newcomer) and orange keyrings. It is getting better; the last order was nearly complete.
- **2. Stocktake** We need to close for the office for UKSO to do a full stock take. This means that all processing needs to be put on hold. The website will stop taking orders for a weekend October / beginning November.
- **3. Charitable status** All directors need to sign Trustee eligibility declaration for submission to the Charity Commission. Lucy and Micky signed today, Bonita, Alex and Andy still to sign as were not able to attend last Office meeting.
- 4. GDPR We have completed and agreed on the Privacy Notice for website for GDPR compliance

General report: We are in the process of reorganising our subcommittee to better reflect the diverse nature of our committee. The main change is that there will be 5 subcommittees underneath our main committee. This will help focus discussions.

Share Review - Been reduced to 3 groups due to the non-commitment of some members. 22 shares reviewed since the last Region. We got the following from a member sent to us — "...I really need to be at home with the children at the moment, but I also really need this fellowship.

Listening to shares online is so comforting to me. It's my lifeline. It has deepened my identification with NA as the solution to my problem at a time that is so painful I'm surprised I haven't walked away. Instead, my faith in this program and love for the people on it has grown. Please feel free to pass this message to the wonderful people on the committee who make sure the shares are there for an addict like me when I most need them. I am very grateful."

Distance Sponsorship - Distance Sponsorship continues to be busy, for the last couple of months So far over 40 requests since the last report and from all around the worldwide. A lot of the requests DS is getting seems to be no starters and we get one email and a lot never reply to the email I send to them. So Instead of linking first, just trying to get some communication going or there no starters. DS is really struggling for female's sponsors. This first time that we have females waiting for ATM for females sponsors. Please can RCM's take this back to your areas. DS previously expressed, we are always looking for members to get involved with Distance Sponsorship. The sponsee's that DS have linked to sponsors in the last 8 weeks Sponsee's - 6 male's in the UK, 2 Female in Holland, 2 Female in the US, 1 Female in the UK. New Ratified Sponsors - 1 Female sponsor in UK, 1 Male sponsor in Holland. New guidelines brought that need to be ratified.

Helpline - All going well. Need volunteers as always. New committee meeting every 2 months. New WhatsApp guidelines to be ratified. **Online Meetings** - All going strong with an average attendance of 20-30.

Suggestions or recommendations to RSC: A workgroup should be set up to establish guidelines around GDPR. I met with a member who has experience and would be willing to help. This would take a few months to do as we would need to establish what personal data is being stored and how it is used before the guidelines could be formulated. We would hope to provide guidelines for Region and its subcommittees, ASCs and their subcommittees and for Groups too.
