Safehaven is open to LSC going into the venue the LSC chair is making progress through email connection with the lead. It was agreed that chair will send the dates of meeting with the venue by The next Thursday of the meeting. LSC reports that the prison connection has broken down with NA. There is no personal details and believed to be catastrophic damage. Distribution of posters for the LSC is vital and the current service member does need support with distribution. During the meeting it was discussed as to why the GSRs are not able to as trusted servants to take the posters in and around Sussex to appropriate venues. **Literature Report**

Literature secretary has had issues ordering in small amounts as much was out of stock. It was put to the group that an order was to go in for £1700 this would come out of the Prudent reserve of £3500 which has run for two months. Order has been placed as it was voted on and agreed.

It was brought to the group that the online daily meeting is not reporting to the ASC and being accountable for the funds which is told to be going directly to NA. This is something that members felt they wanted to know. Who is paying the online fee? This meeting is 5 days a week.

An ASC Steering Committee meeting was held to discuss options for the physical mailbox for the ASC which was quite expensive. An alternative whereby we pay for any mail actually delivered was agreed. Also, a member who had been going to Ford prison for 2 years but was only ratified for the second of those two years (was acting independently for the first year) put in a claim for 2 years' worth of travel expenses. It was agreed only to reimburse him for the period in which he had been ratified.
