GMANA had put forward a motion re: sustainability of literature which they didn't feel was answered properly by the WSO....it will be picked up in new business. UKSO had a loss last year but a surplus the ear before.....UKSO actually reduced prices....but all associated costs, transit, price from WSO etc went up. UKSO can't make another loss. Aiming for £2000 surplus this month

NW London: Question re: HMP vetting times.... Lack of people stepping forward for service. Suggestions: People going to share on the value and purpose of service. London convention early bird price over but still cheaper to buy ahead of time. A role was proposed for the London convention 'wellbeing and kindness chair' to mitigate risk of inappropriate behaviour that hasn't been taken yet (concerning)...Londoners wanted to take it.

UKSO:

Deficit in accounts but cash okay. Lit sales are up but so are costs....so prices up after a long hold. UKSO are receiving lit direct from China now instead of being re-shipped from Europe. Now having to go via Cape of Good Hope though! Care: Please could those who order make sure they get their sums right. There is also money outstanding (>£10K).

Audio version of 6th edition of Basic Text is complete – UKSO need to sign a contract which will allow t to go into circulation.

Fellowship Development (Stuart)

- Have met with local FD committees...(there needn't be an FD committee for an area to have an FD rep). They

- A success: Has increased engagement in Scotland. Building Stronger Home Groups presentations delivered locally. Environmental Scan has about 80 responses to date.
- Scans can be offered to Areas (e.g. Glasgow) to assist with inventory type activities.
- FD have offered to create a grab sheet of collated information of how to attract people into service...will be sent with action list post each Region.
