The Region guidelines:

This document really does need some thorough scrutiny. There are a lot of changes that are getting made, and we all need to be involved, to actively ensure that many of these proposed changes are properly amended.

For example:

- Quoracy, or non-quoracy, with votes being given to steering committee members to attain it.
- Steering Committee changing its name/status to Administration Committee.
- Many of us feel that it should be written in to these guidelines that an atmosphere of recovery should be established and maintained throughout.
- There is a need to formulate more clearly the means of bringing forward any proposal for a vote of no confidence.

List goes on and on. Other Areas also have concerns too.

I will post a copy of these guidelines along with the Area minutes. If members could take the time to quickly scan through them and get some feedback to me that would be great.

• In the meantime, I would like an area conscience with the issues that I've already highlighted above.

UKSO: We currently have 2 Directors in post.

Elections for additional directors are scheduled to begin at the upcoming region.

Job descriptions, guidelines will be posted with the minutes.

I would urge that we do all we can to put forward a member/s, from Sussex Area of NA to stand as a director/s of UKSO.

- I have joined another Ad-hoc committee dealing with the progress of the development of the UKSO. I attended a meeting of this committee on Sunday morning in a room at the London Convention. The remit of the Ad-hoc team rests basically upon the potential to extent the services that UKSO provides. Possible changes to its current location and the logistics involved etcetera.
- I have however, managed to place an initial priority to be given to re-establishing and reinforming the UK fellowship of what services the UKSO currently provides. Regardless of whether they are being utilised to their full potential or not.

It is long overdue for healing this mis-understanding and mistrust between UKNA RSC and the UKSO.
