#### Sub-committee activities:

Sussex Area now has a **Local Services Committee (LSC)**. This committee is responsible and accountable for all PI/H&I and Outreach for Sussex Area of NA.

**HMP Ford**: We now have support for bringing H&I meetings back into HMP Ford. Saturday Mornings and Thursday Evening. So far, we have put forward 7 members for the vetting process. The process requires a great deal of information, address records, employment records, CRO. There are limited time frames for completing this on-line, computer skills and patience required.

**HMP Lewes:** Having sought help from the NHS services provider within Lewes prison. We have been informed that currently, 2 NA meetings regularly take place, run by inmates themselves. We are trying to gain a little more information about these meetings.

Elysium Hove: (formerly the Priory) Regular weekly H&I re-established at this rehab facility, Friday 6.30 -7.30pm.

**Langford Centre, Bexhill** Regular H&I meeting (males only) Monday afternoon 2pm-3pm. We are also preparing to facilitate regular meetings for women within this facility.

**Recovery Lighthouse, Worthing.** A new Tuesday evening weekly H&I meeting began 6<sup>th</sup> February '18 in this rehab facility. Facility are keen to purchase NA literature via UKSO.

**Stonepillow Hub, Chichester.** Regular weekly meeting Thursday afternoon 1pm -2pm. This venue space is available for another NA meeting if anyone wishes to set one up.

**William Collier House, Brighton.** Request form this facility for PI/H&I presentation, which took place, 5pm 17<sup>th</sup> January 2018. After several follow-up calls and email exchanges, a time and day have been agreed to bring regular H&I meeting into WCH. Meeting arrangements finalised and will start Wednesday 7<sup>th</sup> March '18.

**Pavilions, Brighton.** Although we hold a fully open self-supporting NA meeting at Pavilions, they have asked if we would like to hold regular H&I Panel presentations to clients as an introduction to NA.

**Royal Sussex County Hospital, Brighton.** We had a meeting with the manager of the substance misuse team at the Hospital at 2.30pm 23<sup>rd</sup> January. The details from this meeting will be put before the NHS Trust managers when hopefully permission will be granted to move things forward.

Or at the Region, September '16 in Cornwall? <u>The meeting was held at the request of the RCM's, who also agreed that Region Vice Chair attend to facilitate it and report back to region.</u>

The question was replied to: By both Matt, as Region Chairperson, and Chris as V. Chair of Resources. Both of whom asserted, that the minutes from **that** meeting **were** distributed at the Region in September 2016. <u>However, having trawled through the pre-region mailings for that time, these minutes, it would seem, were not distributed as claimed, in January 2018</u>

Given the fact that these minutes had been distributed and sent out to the members present at the meeting within good time, including Matt M. (Region V. Chair)

It should have been incumbent upon the Region V. Chair (Matt M) to have given a report about this to: (A) To the steering committee during its mid-cycle meeting in August 2016, (B) A full report should have been presented to this body at the September 2016 RSC in Truro, Cornwall.

Was a report given by region V. Chair at the mid-cycle August 2016 Steering Committee Meeting? If NO? Why not?

If YES? Then please could we all have a copy now?

Why was no report given at the September 2016 RSC?

Why were these minutes not distributed openly to RCM's who had requested the meeting take place? A: Still insistent that they were sent out.

## The Region guidelines:

This document really does need some thorough scrutiny. There are a lot of changes that are getting made, and we all need to be involved, to actively ensure that many of these proposed changes are properly amended.

## For example:

- Quoracy, or non-quoracy, with votes being given to steering committee members to attain it.
- Steering Committee changing its name/status to Administration Committee.
- Many of us feel that it should be written in to these guidelines that an atmosphere of recovery should be established and maintained throughout.
- There is a need to formulate more clearly the means of bringing forward any proposal for a vote of no confidence.

List goes on and on. Other Areas also have concerns too.

I will send out a copy of these guidelines along with the Area minutes for everyone. I'd like to invite everyone to read and comment on them.

Q: Have we made any progress with putting a bid together to host Region?

The Region for July will be held at Preston again.

Thanks everyone who helped with the CAR report. I was able to collate the votes from us and handed the results to our Regional Delegate to take to WSC later in the spring.
