The move of the office has been set back by approx. 3 months due to the lockdown. Directors will visit the shortlisted properties in early July with a view to start negotiations over a lease. We must be confident of the ability of UKSO financially to commit to a lease before signing it, and we will be taking legal advice before any lease is signed.
